II. Coach & Liaison Reports

A. Girls – The girls had their banquet on March 18 went really well. Some things that need to still be done is equipment turn in as well as pushing the girls to start attending postseason club workouts. We also have to encourage Nate Graham strength training to the girls. We have two girls going to the next level and wrestling in college. Ona is wrestling at Eastern and Lily is wrestling at York. Hattie Mack got one of the scholarships for wrestling at Lehigh that was announced at the LL. We gave out for the first time that Jude Bervinchak award which went to Cleona are gonna start looking into getting some dates for tryout nights for high school kids that aren't involved in any other sport just to come and see if they want to try. We are loaded in the low and middle weights but we have a large gap to fill from 155 pounds to heavyweight.

B. Youth – The banquet is coming up Sunday. Nathan Pfursich medaled at Keystones. Five completed at PJW's and did well especially with as far out it is after qualifier. We're gonna start up the open mats probably Sundays. Beckman is taking two teams to Virginia Beach. Nathan, Thor, Connor, Trent, probably missing some, but we got 7 or 8 guys between the youth and junior high. Maximus is going with Team Nauman as well as Joey. Brady is also going. We will have 10-12 guys down in Virginia Beach Memorial Day weekend, so we got a good crew going down there. We have a couple guys qualify from MAWA's. We are going to get together a summary of all the off-season opportunities for everybody for the banquet. LAW and Stellar York we are good on credits. Nauman we have to top up. We need to have a discussion was that the credits would only be available to people that had participated in fundraising. Also it needs to be relayed that while Nauman does not have an annual fee, LAW doe have an annual \$30 fee that needs to be covered by the wrestler.
